



INFORMATION CLAUSE ON DATA PROTECTION

Basic information on data protection

Data handlers: REIAL CLUB DEPORTIU ESPANYOL DE BARCELONA, S.A.D. (henceforth, "RCDE") (CIF A-08.357.139), located at Avenida Baix Llobregat, 100, 08940, Cornellà del Llobregat, Barcelona.

Purpose: (i) Maintain the contractual relationship and maintenance of members/season ticket holders, including access to the member area of the website, facilitating the processing of procedures through this format, such as making payments, financing season tickets, updating details, as well as other procedures related to the membership/season ticket card and associated services; (ii) Manage the contractual relationship derived from the purchase of tickets, processing the request for tickets for matches played outside our facilities; (iii) control access to our facilities and guarantee the safety of those who come to the stadium, as well as prevent and avoid violations of people's fundamental rights, such as hate crimes and discrimination, taking security measures for prevention (for example, recording the data from the membership/season ticket cards), as well as, where appropriate, handling infractions according to the Disciplinary Regulations; (x) Send newsletters and commercial communications related to the activities, products, services and promotions of the club and its sponsors and collaborators, by any means; (v) Send commercial communications regarding RCDE products or services that are similar to those that were initially contracted; and, (vi) preparation of a profile with the data provided directly through the registration forms and other data that is inferred from the web interactions that you carry out with RCDE, in order to offer you experiences, promotions, information, as well as personalised products and services relevant to your interests, as well as those of sponsors and collaborators.

Legal basis: The aforementioned purposes are legitimised by the following legal foundations: (i) execution of the contract; (ii) execution of the contract; (iii) legitimate interest; (iv) consent; (v) legitimate interest; and (vi) consent.

Recipients: In general, we do not pass on your data to third parties, except in the following cases: (i) those that are necessary in accordance with the law; (ii) to the suppliers that provide us with certain services (eg. virtual infrastructure services, cloud computing, etc.), which may have access and/or process your personal data in their capacity as data processors.

Duration: For the period of the contractual relationship with RCDE, during the time necessary to fulfill the purposes previously described. Likewise, if applicable, as long as the consent given is not withdrawn. Once said period has expired, your data will be kept, duly protected, until the timeframe for possible legal responsibilities of all kinds has expired.

Rights: Access, rectification, opposition, deletion, limitation to handling, portability and the right not to be subject to decisions based solely on automated treatments. You have the right to oppose the processing of personal data at any time. Likewise, the consent given at any time will be revocable. These rights may be exercised through a communication to the address of RCDE or through: dpd@rcdespanyol.com. Likewise, you can make a claim to the controlling authority at any time. International transfers: Those resulting from our relationship with service providers in accordance with Chapter V of the GDPR.
